Effective November 30, 2015

There will be a \$2.00 monthly fee for paper statements (no fee for those under 18 or over 65). In order to avoid this fee go to our website <u>www.faithcu.com</u> and sign up for Home Banking. After you log in click on the "Self Service" tab. Then click on the "Additional Services" tab. Finally, click on the "E-statements" tab. This will set you up for electronic statements. Each month you will receive an email to let you know your statement is ready. Remember, this is the only way to avoid a monthly statement fee.

# **Dormant Accounts**

Are you using your account? Did you know that using your account at least once a year eliminates you from being assessed a dormant account fee? By law, if your account has not shown any activity for five years (currently since July 1, 2010), funds are turned over to the State of Ohio, after attempts to reach you have been unsuccessful. It may not seem like it, but 5 years goes by quickly. Do not allow your funds to be sent to the State of Ohio Unclaimed Funds. Send a deposit today and update your account information. We must have your current address, phone and beneficiary information.
