## Seniors Beware

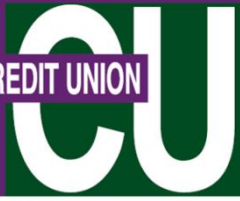
Each year millions of our senior citizens are victimized by financial fraud or theft. Here are some suggestions to protect you and your loved ones:

## Say No to Taxes

Congress is using a “wipe the slate clean” approach, meaning all existing tax exemptions, including credit unions’, must be re-affirmed or they will be eliminated. Instead of just defending the credit union federal tax exemption, we as a Movement are now fighting for the exemption to be put back on the table.

We have to stand up and be heard! While more than 3,000 messages from Ohioans have already been sent, millions are needed in order to succeed. Take action now: visit [www.donttaxmycreditunion.org](http://www.donttaxmycreditunion.org) and send pre-written messages to your members of Congress. It does not make sense to tax credit unions to pay down the national debt. For every \$1 in new credit union taxes, the government wipes out \$10 in benefits to credit union members.

We want Congress to hear at the outset of the tax reform debate that credit unions are tax exempt because they are **not-for-profit**, they return benefits to members, and **members are owners**. So, a tax on credit unions is just another tax on 96 million Americans. Just say NO!
