These loans should help prevent debt collectors from threatening seniors with selling tax liens and avoid high interest rate cards and exorbitant payday lenders. In addition to the loan, financial counseling and other free financial services will be given to the borrowers.

It is a tragedy for seniors to lose the homes they have worked all their lives to obtain. This program is part of the Clinton Global Initiative Working Group on Financial Opportunities.
